 - Sam S - go to GP or hospital, people in Slough - specifically trained for this. Can go to various health centres, but this is the more emotional side.
- Louis P - Movement/progress to get more centres that are closer than Slough
 - Andrew R - Came up in OUSU elections. There are only 5/6 in countries. We're very low down on the list. We should support one for city but won't happen soon.
- Dougie - Train route to London, goes through Slough.
 - Flossie - discretion of the welfare budget for the individual and the situation itself.
- Anna HB - Things need to be done as soon as possible. This is where you'd need a taxi.
 - Sam S - STD check go to GP etc. but this (slough) is more emotional.
 - Flossie - Under impression that this is ideal place for after sexual assault.
